Contact lens benefit

With the *Lincoln VisionConnect*® plan, your employees get a contact lens benefit. When members purchase from the Covered Contact Lens Selection,² their covered-in-full benefit includes fitting and evaluation, up to four boxes of contact lenses, and two follow-up visits to their vision care provider. Members simply make the copay, if any.

If they select lenses not included in the Covered Contact Lens Selection, members will receive an allowance toward fitting/evaluation fees and their contact lens purchase (material copay does not apply to the allowance).

Members can also take advantage of additional discounts through an online ordering program once they receive their first order of contact lenses from their provider. Members can buy contacts at a discounted rate by ordering at www.myvisionlenses.com.
